

Enforcement and the Rule of Law Gap

The criticality of enforcement of accountability under the law through enforcement is a central focus of the EROL report:

"Environmental laws have grown dramatically over the last three decades.... Too often, [however,] implementation and enforcement of environmental laws and regulations falls far short of what is required to address environmental challenges.... These shortfalls are by no means limited to developing nations: reviews of developed nations have found their performance on environmental issues lacking in certain respects. In short, environmental rule of law is a challenge for all countries."

"Enforcement of law is perhaps the ultimate expression of state political will and seriousness of purpose, and compliance is the strongest indicator of environmental rule of law. Even where compliance is pursued and achieved, it can be difficult to sustain over time without government commitment of resources and capacity, private sector conformance, and near-constant civil society oversight."
