Dear Colleagues,

After a particularly long and wet Winter here in Europe we head into Spring encouraged by the publication of the revised Environmental Crime Directive (ECD) EU 2024/1203



https://eur-lex.europa.eu/legal-content/EN/TXT/?uri=OJ:L_202401203 on 30 April 2024 which includes new environmental offences and renewed emphasis on effective, dissuasive and proportionate sanctioning for those committing them.

The focus and breadth of the new Environmental Crime Directive, which places emphasis on training, collaboration and transnational co-operation are quite ground-breaking. These have always been special areas of focus for ENPE and our members because of the nature of our network. Crucially, however we are now armed with new tools to face the challenge of environmental criminality.

This has led to some fascinating case studies which have been presented and discussed at these events. Moving forward, our ENPE membership continues to grow and our outreach extends and we welcome our most recent members from the Republic of Armenia and Serbia.

Latest news on Environmental Legislation from the European Commission

The European Parliament adopted the new Environmental Crime Directive, with its updated register of environmental offences following a vote by Members of the European Parliament (MEPs)



on 27 February 2024. The new Directive, **EU 2024/1203**, published on 30 April 2024 is available for download here: https://eur-lex.europa.eu/legal-content/EN/TXT/?uri=OJ:L_202401203

This new Directive will address large-scale pollution crimes such as deliberately-started forest fires and intentional pollution of air, water and soil. There is provision for enhanced sanctions including prison terms and the need to compensate for, and reinstate damage caused. This is intended to ensure the handing down of effective, dissuasive and proportionate sanctions. Member States will be required to organise training for police, prosecutors and judges involved in the enforcement of environmental crimes. They will be encouraged to collect and share data to better understand the landscape around this huge problem and to enable better targetting of resources. We look forward to working with our members and the Commission in its implementation.

ENPE Board Proposals

ENPE is constituted as an aisbl under Belgian company law and is run by its officers under a formal company structure. The President of ENPE is the Managing Director of ENPE aisbl and other Board members are Directors. We have been discussing changes to our Company structure for some time, primarily as a result of Brexit but also to ensure continuity in the running and development of the network,

At a meeting in Brussels on 12 April 2024 the Board formally agreed some proposed changes to our structure. From 10 October 2024 Robertus (Rob) de Rijck (NL) will take over as ENPE President, Lars Magnusson (SE) will move from the post of Secretary General to that of Vice-President alongside Jean-Philippe Rivaud (FR) who remains our International Vice-President. Anne Brosnan (UK) will remain as ENPE Board Member and will take up the role of Secretary General, ably assisted by Shaun Robinson who will remain ENPE Project Manager but also Head of Secretariat. Aisling Kelly (IE) remains Treasurer. David Smith (IE) and Antonio Vercher remain Board Members, as before and we will be asking for further volunteers to join our ENPE Board at our AGM in Cork, Ireland in October. These changes will not take place until ratified by our members at our AGM in October. We hope you will feel able to endorse these proposals in due course.

Italian Constitution changes to protect animals and biodiversity – LAV conference 22 February 2024

On February 22, 2024, two years after their Constitutional Reform to protect animals and biodiversity, the Italian environment and animal protection group LAV, in co-operation with members of the Italian Parliament, organized a conference at the Italian Parliament titled "Making Concrete the Protection of Animals and Biodiversity Two Years After the Approval of the New Article 9 of the Constitution." The conference featured the presentation of research commissioned by LAV to the University of Milan – Bicocca which looked at this issue, and published in the federalismi.it journal.

The constitutional law no. 1 of 11 February 2022 amended Article 9 of the Italian Constitution to read as follows: "The Italian Republic protects the environment, biodiversity, and ecosystems, also in the interest of future generations. State law shall regulate the methods and means of safeguarding animals."



This marked a crucial change in the Italian legal system itself, recognising the principles of protection of the environment, biodiversity, and ecosystems as distinct from and autonomous with respect to the human dimension and in an explicit way. The research considers the position of biodiversity and animals in the amended article 9 of the Italian Constitution and concludes that the new constitutional provision is first of all a pressing appeal to effectively implement a new fundamental principle – "the animalist

principle" – that is now enshrined in the Constitution and therefore endowed with the force of the highest-ranking positive law.

The conference provided an informative opportunity for discussing the general principle of protection in the context of the reform of the Italian Constitution and how to work to respect the new regulation in different areas and to enhance the protection of biodiversity and animals in Italy. Magistrates, including the President of the Supreme Administrative Court and the Prosecutor General of the Criminal Cassation University, Professors from Milan, Bologna, Rome, and Naples, Police Commanders, and experts in the field, attended and contributed to the discussions.

BIOVAL - a project update





The 'BIOVAL' project is an ongoing European Union-funded joint initiative involving The European Union of Judges for the Environment (EUFJE), The European Union Network for the Implementation and Enforcement of Environmental Law IMPEL) and ENPE BIOVAL (eufje.org). The project has developed a non-binding, practical

instrument to value ecological damages in court. The project continued to make good progress in 2023 with the BIOVAL methodology successfully used in a first case in Belgium in March 2023. This decision was confirmed on appeal in January 2024. More details on this are provided here: https://biovaltool.eu/ with a summary of the first case included below:

On 7 March 2023, the Criminal Court East-Flanders, Ghent division, ordered financial compensation to be paid, for illegal catching of starlings, of 15.400 EUR (200€ x 77 starlings), using the BIOVAL calculation method (extinction risk: 2€ + cultural value: 166€ + ecological value: 16€ + contribution to prosperity: 16€ = 200€ per starling). This decision was made considering that restoration in nature was impossible and even prohibited by law (Flemish Species Regulation of 15 May 2009). This *civil* compensation was to be paid to the Flemish Environment and Nature Fund for environmental restoration purposes (Mina Fund – a public fund financing prevention and remediation projects relating to nature and the environment) and is distinct from the *criminal* sanction that was ordered (120 hours community service).

The decision was appealed. On 26 January 2024, the Court of Appeal upheld the decision, considering that compensation was the only possible form of recovery, as the breeding and release of starlings to repair the damage caused to nature. The court approved the amount of the compensation calculated through the BIOVAL methodology, and approved the attribution of the compensation to the Mina Fund as a public fund that is "partly funded according to the principle 'the polluter pays', in this case 'the perpetrator pays'" and whose purpose is "to cover the costs of decontamination and restoration not covered by the revenue from levies and fines". The court added that "This compensation restores the legal situation".

This is a major step for BIOVAL, with judicial approval of its methodology. As can be seen from the website, the list of prices and case law that legal practitioners and in particular judges and lawyers will be able to refer to in their own cases, is being finalised. Hopefully this will inspire more countries in the European Union, as we know that about 10 EU countries have attempted to set forth or adopted methods to calculate such compensations. BIOVAL has also triggered a lot of interest recently, from legal practitioners and the press.

Collaborative initiatives and new technologies to prevent forest fires in Spain

The Office of the Prosecutor for the Chamber of Environment and Urban Planning in Spain (Ministerio Fiscal, Medio Ambiente) has taken a proactive stance in addressing risks posed by forest fires by working collaboratively with other enforcement agencies, including SEPRONA, Municipal Police and Forest Agents, to deploy innovative technologies such as drones and satellitne imagery to map and monitor area of high risk.

A key objective is to continue the strategic and pre-emptive work started by the Office in 2018 to ensure preventitive plans were in place and workable in all municipal authorities with forest land. This is in reocgnition of the increased threats due to Climate Change as evidenced in the last few years where high tempreatures and winds have caused an unprecedented number of devestating fires across Spain.

New technologies such as drones will be used to map and monitor at risk areas, as well as report on the physical parameters, including planning, to ensure compliance with preventiative plans. As an example of both mitigation and adaptation to Climate Change, this initiative, dirven by the Office of the Prosecutor for the Chamber of Enviornment and Urban Planning, is an important step in reducing forest fire risk and therefore the associated devestation of the environment.

Joint IAP-UNEP Webinar: An Introduction to Environmental Crime

ENPE Vice-President Rob de Rijck presented at a webinar organised by the International Association of Prosecutors (IAP) Global Training Academy and the United Nations Environment Programme (UNEP) on 20 March 2024 which provided an introduction to environmental crime for IAP members.

The webinar was to assist prosecutors to increase their knowledge of environmental crimes and to better understand the convergence between environmental crimes and other forms of criminal activity. Colleagues from INTERPOL as well as the IAP and UNEP also contributed to this event and a particular area of focus was the importance of collaborative approaches in prosecuting environmental crime, in particular through the roles of the different enforcement networks, including ENPE. As a network, ENPE works closely in partnership with

the other European environmental crime enforcement agencies and organisations. In co-operating and collaborating to fight environmental crime, we are most certainly 'stronger together'. [organisation images taken from webinar programme].

ENPE President Anne Brosnan, Project Manager Shaun Robinson, together with Hannah Wooldridge of the Environment Agency (England) Waste Shipments and internation Engagement team met with The Australasian Environmental Law Enforcement and Regulators network (AELERT) Chief Executive Officer Mr Greg Abood to discuss common international environmental enforcement objectives, potential collaboration opportunities and, in particular, the forthcoming AELRT-INECE Global Summit on Implementing and Enforcing Environmental Law.

AELERT, together with the International Network for Environmental Compliance and Enforcement (INECE) and their international network partners will convene the 2024 Global Summit on Implementing and Enforcing Environmental Law on November 6-8 in Brisbane, Australia - "We are better together: A Summit for regulators that will strengthen global cooperation and capabilities to better implement environmental law and build trust and confidence in regulatory systems".

This action-orientated event will strengthen worldwide cooperation and collaboration among regulatory practitioners and agencies to grow our collective capabilities and solve complex regulatory and law enforcement problems. [details from ALERT-INECE Summit programme and abstract documents]

ENPE at the WaldrappTeam Conservation & Research Symposium & panel discussion: "New approaches and technologies against illegal bird hunting"; 18-19 April 2024, Parc Zoologica, Verona, Italy

The introduction from the symposium programme provided great context for this important event which was held at the Verona Zoological Park and also online: "For more than 20 years, alongside the reintroduction of a

migratory Northern Bald Ibis population in Central Europe Waldrappteam has been implementing a campaign against illegal bird hunting in Italy. Despite a lot of effort only one perpetrator has been prosecuted and convicted. This disproportion is representative - illegal hunting is still a low-risk crime and a significant threat to biodiversity, not just in birds and not only in Italy."

ENPE Project Manager Dr Shaun Robinson presented in the opening session, explaining how ENPE had evolved as a prosecuting network and in particular the work completed so far in strengthening wildlife crime prosecution. Mention was made of the ENPE Wildlife crime Working Group and the joint training pack delivered in conjunction with the UNEP Convention for Migratory Species (CMS) which focusses on the Illegal Taking and Killing of Mirgratory wild birds in the Mediterranean region.



Speakers and delegates from across Europe were present with the welcome speech provided by Dr Johannes Fritz, Project Manager, who set out the objectives and also touched on how far the project has come over the past 20 years. Of particular interest in Dr Fritz's second presentation, was the obvious success of this reintroduction project and the extraordinary lengths the team has gone to, to preserve, nurture and protect these amazing birds. That said, there is still much work to do, with most fatalities still due to anthropological activites, not least - illegal hunting.

United Nations Development Programme (UNDP) webinar on the Application of the EU Directive on Protection of the Environment through Criminal Law for colleagues in Bosnia and Herzegovina

ENPE Waste & Illegal Pesticides Working Group Co-chair and Permanent Representative for the Czech Republic, Katerina Weissova delivered an online presentation on 15 April 2024 on the application of EU Directives in relation to environmental crime as part of a United Nations

Development Programme (UNDP) webinar for prosecutors and judges in Bosnia and Herzegovina.

The webinar was part of a year-long UNDP project which is seeking to strengthen the environmental Rule of Law in Bosnia and Herzegovina whilst recognising the global challenges of environmental crime. A key component of this is to improve access to environmental justice through supporting people-centred public policies and services. As an EU candidate country, aligning the objectives and initiatives in environmental legislation with the EU is a high-priority issue, something that ENPE is always keen to assist with.

The recent publication of the updated Environmental Crime Directive EU 2024/1203 with its additional offences included adding depth and breadth to how crimes against the environment can be brought to courts, makes this type of awareness raising and training so important. In particular, in ensuring that countries that are seeking to join the EU are fully in line with the legislative tools and processes in place to protect the environment.

Our colleagues at the UNDP were very impressed with Katerina's presentation and are looking forward to collaborating again in future. Seatrade reaches settlement with Dutch Public Prosecution Service

Dutch ship owner Seatrade has reached a settlement with the <u>Dutch Public Prosecution Service</u> following the illegal export of four ships to India, Bangladesh, and Turkey for scrapping back in 2012. The agreement entails the payment of a total sum of 5,650,000 euros. Preventing further prosecution, fines totalling 2,650,000 euros were imposed on the shipping company and two of its directors, with an additional settlement of 3,000,000 euros.

On 15 March 2018, the District Court of Rotterdam found Seatrade and two of its directors guilty of violating the European Waste Shipment Regulation. However, this <u>initial ruling</u> was annulled by the Court of Appeal in The Hague on 30 June 2020, due to procedural irregularities, and a new trial was set to begin.

European legislation prohibits the export of toxic end-of-life ships from EU waters to non-OECD countries, and mandates specific procedures for the transboundary movements of hazardous waste within the OECD. Acknowledging their breach of existing rules applicable to ship recycling, the management of Seatrade expressed regret for the actions taken and committed to ensuring future compliance with all relevant laws.

UK, England – Businessman ordered to pay £54,900 for historic waste crimes

- Proceeds of Crime Act (POCA) hearing orders Michael William Leah to pay £54,900.
- Sum to be paid within three months.
- When he was convicted of six offences in 2011 he paid only £100

A Penzance businessman has been ordered to pay £54,900 for crimes he was convicted of 12 years ago, after he previously had paid only £100 in recompense.

Michael William Leah, 59, of Blue Horizon, Castle Gate, Ludgvan, near Penzance, Cornwall, England, UK appeared before Truro Crown Court on Friday, in a case brought by the Environment Agency under the Proceeds of Crime Act.

He was ordered to pay £49,900 for a confiscation order, plus £5,000 in costs. The sum has to be paid within three months, otherwise he will be sent to prison for 12 months.

The court heard that in August 2011, Leah was convicted of six offences related to illegally depositing controlled waste at sites near Newbridge, Gweek and in St Ives, for which he received a suspended prison sentence and made subject to a confiscation order. Though he had made £50,000 through his crimes, at the time of his conviction he was bankrupt and had only £100 to his name and was ordered to pay that in recompense.

Since then, he has inherited a property and his case was brought back to court last week following an investigation by the Environment Agency's Economic Crime Unit for reconsideration of the confiscation order. Leah maintained that his home was owned by a trust, but a paper trail showed that he was a trustee of that trust, with access to more than £700,000 in assets.

Now running a haulage company, Leah's three main contracts are worth over £200,000 and he owns vehicles worth a total of nearly £60,000. Following the hearing Ashley Davies of the Environment Agency said:

"This case shows that criminals who think they have got off lightly can think again. We'll still come after them if their fortunes change."
